Reference to the subject matter as stated above-

After considering thoroughly over the documents produced by the school Management alongwith affidavits and recommendations by District Education Officer(Sec.Edu.)and Director, Education Department(Sec.Edu.), Punjab, Chandigarh, the required no objection . Certificate is issued by the Govt. of Punjab on the terms and conditions mentioned below:-

In case of any complaint/ on inspection, if this fact comesforth in future that at the time of receiving No objection certificate, you have filed application before the Govt. on wrong information or you are not abiding the instructions issued by the Punjab Govt.from time to time and thus, the conditions mentioned in written in the Affidavit are not being followed, then in this situation, the No objection certificate can be taken back at any time.

Study of Punjabi upto Matric Standard will be compulsory in your school and C.B.S.E, New Delhi will surely arrange for taking the examination of Punjabi in such schools and it is also stated herewith that failing in doing this, the no objection certificate will be taken back immediately.

The school management will completely follow the notifications issued by the Education Department Punjab Govt. under R.T.E. Act 2009 and rules and regulations of R.T.E. Act 2009 made for Punjab State.

After taking affiliation from C.B.S.E, New Delhi, School Management will be bound to give salary and other allowances to Teaching and Non-Teaching staff of the school through account payee cheques like govt. employees. In failing, no objection certificate will be taken back immediately.

You yourself and your management will also assure that whenever any information is demanded by the Education Offricer of your District or by any senior authority of Education Department, then required information will be rovided to him and required co-operation will also be given to him.
